Family Home	An individual approved by DPH to provide care in their own home for up to six full time children and, during the school year, three additional children before and after school.
Exempt School	A child care program administered by a public or private school system or by the Department of Defense.
Exempt Program	A child care program administered by a municipal agency.
Relative care	Care provided by a close blood relative either in the home of the relative or the child.
Care in a child's home	Care provided by an unrelated individual in the child's home.
